## Pro-Lifers Commend President Trump for Selecting Neil Gorsuch to Fill Scalia's Seat on Supreme Court

January 31 - President Donald Trump nominated Judge Neil Gorsuch, from the U.S. Court of Appeals for the 10th Circuit in Denver, to fill the vacancy created by the untimely death of Judge Antonin Scalia.

National Right to Life heralded the announcement in a press release. "All too often, our efforts to protect unborn children and other vulnerable humans have been overridden by judges who believe they have a right to impose their own policy preferences," said Carol Tobias, president of National Right to Life. "We are heartened that Judge Gorsuch appears to share Justice Scalia's view that federal judges are constrained to enforce the text and original intent of constitutional provisions, and on all other matters should defer to democratically elected lawmakers."

In a 2008 article in *National Review*,

Judge Gorsuch wrote, "[R]ather than use the judiciary for extraordinary cases ... American liberals have become addicted to the courtroom, relying on judges and lawyers rather than elected leaders and the ballot box, as the primary means of effecting their social agenda..."

Gorsuch's 2006 book, *The Future of Assisted Suicide and Euthanasia*, argued against the legalization of assisted suicide and defended the idea that "human life is fundamentally and inherently valuable, and that the intentional taking of human life by private persons is always wrong."

As a judge Judge Gorsuch supported religious liberty by playing an important role siding with Hobby Lobby and Little Sisters of the Poor against the Obama administration's Affordable Care Act.

## Action Alert Please Act Now

The US Senate is expected to be faced with a major pro-life battle over the confirmation of Judge Neil Gorsuch to the Supreme Court.

Pro-abortion activists are preparing an all out assault to block the confirmation. As they have done in the past they will use every dirty trick imaginable to twist Gorsuch's words, malign his character and destroy his reputation.

The attack against Judge Gorsuch will be lead by powerful pro-abortion Senator Chuck Schumer (D-NY) and his band of

pro-abortion Senate Democrats.

The media will join the effort to prevent confirmation by presenting biased and partial coverage to spread misinformation.

It appears that Schumer and his allies will attempt to launch a filibuster to obstruct Gorsuch's nomination. Whether that obstruction succeeds will depend on how many Democratic senators break ranks -- and on whether pro-life Republican senators take every step necessary to ensure that Judge Gorsuch is confirmed.

# NPRC President Preaches at Funeral of Norma McCorvey, “Jane Roe” of Roe vs. Wade

On February 18, 2017, Norma McCorvey, who was the plaintiff “Jane Roe” in the 1973 Supreme Court decision Roe vs. Wade, which legalized abortion, passed away at the age of 69. Norma had become a good friend of mine since 1995, when she accepted the gift of faith and baptism and became 100% pro-life. I was privileged to be one of her spiritual counselors and in 1998 received her into

the Catholic Church. I officiated at her funeral service.

On that occasion, I reminded the worshippers that Norma never appeared in court and never had an abortion. When she heard about the outcome of the Roe

case, she was not elated, but devastated. Even when she was the ‘poster girl’ for legal abortion, she confided to the pro-abortion leaders that she thought abortion was wrong, and even while working in an abortion clinic, she would counsel women against it. She jumped off the poster, because she never really fit on it to begin with.

When I first interviewed her after she became a Christian, I started by saying, “So you are the Jane Roe of Roe vs. Wade,” and she replied, “No, I used to be Jane Roe, but now am Roe no more. I am a new creation in Christ.” It was that faith in Christ, the only Savior, that enabled Norma, for the rest of her life, to rise beyond the pain and guilt of having been a part of unleashing the abortion holocaust on America.

## Princeton Biophysicist Peter Singer Thinks Intellectually Disabled Less Valuable than Animals

In his apologetics for infanticide, Princeton bioethicist Peter Singer has used a baby with Down syndrome as an example of a killable infant based on utilitarian measurements. (He actually supports infanticide because babies—whether disabled

or not—are, in his view, not “persons.”)

To Singer, moral value (primarily) comes from intellectual capacities, and that means that developmentally and cognitively disabled human beings (also, the unborn and infants) have less value than other human beings, and indeed, a lower worth than some animals.

Were society to ever adopt Singer’s bigoted anti-human exceptionalism views, it would mark the end

of universal human rights, opening the door to tyrannical pogroms against the most weak and vulnerable—you know, the kind of people that the Singers of the world deem resource wasters.

It would also break the spine of unconditional love, as our children would have to earn their place by possessing requisite capacities. . .

And never mind the real capacities of many people with Down (syndrome), which Singer mischaracterizes, or their extraordinary loving natures—which I have yet to see Singer opine much about. To Singer, intellect trumps all.

That’s bigotry any way you look at it, no different than racism, except that his victims are less able to defend themselves.

I have always found it odd that Singer faces little of the opprobrium society metes out to other bigots. Indeed, he was brought to Princeton from Australia and given one of the world’s most prestigious chairs in bioethics—despite not having an academic Ph.D.—precisely because of these attitudes . . .

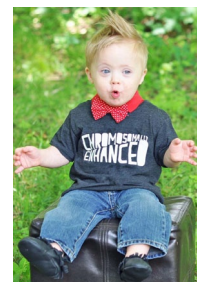
# World Down Syndrome Day - March 21 Celebrating Children with Down Syndrome

## Pro-Life Student Club Wins Battle With Administration



Carmel, Indiana - Carmel High School students won a battle with the school's administration over a pro-life poster which was removed after one student complained that it was “offensive.”

The poster display contained 300 tiny hand painted hearts. Each heart represents 10 babies commemorating the 3,000 unborn children killed each day by abortion.

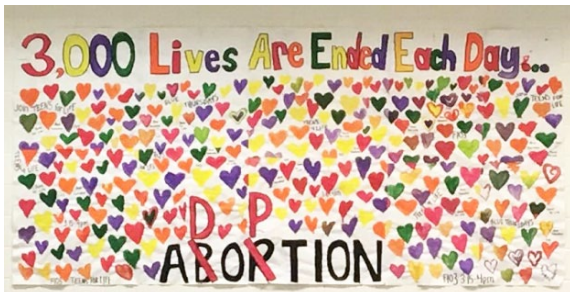
When the administration was challenged for taking down the poster, the principal and assistant principal said that club signs are not permitted to “interfere with what folks are thinking or feeling comfortable with” despite the fact that signs from other organizations promoting controversial ideologies were allowed.

The school personnel had also demanded the Carmel Teens for Life student members sign an agreement prohibiting club members from using the word “abortion” in any club communications, verbal or written, including on Facebook, school posters and other official correspondence.

Liberty Council, a religious and pro-life legal defense law group, challenged the school administration and the pro-life students won.

The students remade their poster and it was displayed for 10 days.
