"Do not despise the day of small beginnings"

What's the old adage? "Each journey begins with the first step?" It's pretty cliché, but as is the case with sayings that become cliché there is the quality of the maxim about it that makes it applicable to many situations. In the light of the Supreme Court decision upholding the federal ban on partial-birth abortions, the NPRC gratefully embraces this cliché as expressing our hope that our society will yet make the long journey out of the barren wilderness that is the abortion culture.

The majority opinion in *Gonzales v. Carhart* is narrow in scope. Of this, there can be no doubt. When one reads it, one senses that plans are already being implemented to work around the ruling, assuring that child killing at all stages of gestation can proceed unabated. But, as is noted elsewhere in this issue (see "Considering *Gonzalez v. Carhart*," p.2, highlighting important language in the decision), we believe a sign has been posted that points to the way out. It is the first such sign that we have seen in 34 + years of wandering in the wilderness.

There are some whom we consider colleagues in the prolife movement who, we suspect, consider the decision to have accomplished little to nothing, and that there should be no rejoicing until all human beings, born and unborn, are protected by the laws of the land. Not content with the thought of a partial victory on any front, they desire unqualified surrender by those who perpetrate the horror of abortion. We understand their unwavering convictions and we share them. We believe, however, that there is a difference between viewing the recent decision as a partial victory versus viewing it, and each battle, as a small victory to be won in the larger war. We embrace the latter perspective.

This is not without biblical precedent. As Zechariah declares, "Do not despise the day of small beginnings." (Zechariah 4:10) These words, given by God through the prophet, came at a time when the idea that God's people could actually accomplish what was in their heart to do could not be imagined. The forces that conspired against them were too great. No one could have believed that the Temple could have been rebuilt and the walls of Jerusalem repaired. But God was at work and through his chosen vessel began to restore the glory that had been lost.

In this spirit, we rejoice to see this triumph of truth over falsehood and dare to believe that it is the "day of small beginnings" for the protection of the vulnerable and defenseless among us. Clearly, the journey is not over; indeed, it has only just begun. It will prove to be a long one for we have wandered deep into the wilderness. Nevertheless, we believe the first step has been taken. As a result, we do not see this merely as a partial victory, which can lead to indifference, but a small victory... a battle won in our struggle toward the triumph in the war for securing the womb as a place of safety for all persons.

Words DO Matter

I was shocked to see the news about the Supreme Court's decision on the Partial Birth Abortion Ban on the front pages of all the newspapers in the stands as I walked through the airport the morning after the announcement. I stopped to read the article of one paper and started crying as I got to the second paragraph, where it said, "Some women come to regret an abortion."

I couldn't believe they used the word "regret." That's our word! That's the key word the Silent No More Awareness Campaign uses to describe the feelings we who have had an abortion, experience. It's whatour signs say:

"I Regret My Abortion."

As I stood in the middle of the concourse blubbering away, trying to read through blurred eyes, all I could think is that for five years we have stood out in the cold at the Supreme Court building and it wasn't for nothing. They saw us. They heard our message. They read our testimonies and affidavits. The Supreme Court finally acknowledged the truth about abortion's second victim. Even though so much of the media ignores our stories, five

of the nine justices helped us be silent no more!!!!

Once the tears subsided, I started praising God for this decision as I firmly believe it marks the beginning of the end of legalized abortion for all nine months of pregnancy in the United States. The barbaric nature of abortion is being exposed.

It seems the abortion advocates also see the writing on the wall. A few days after the PBA decision was handed down, the Freedom of Choice Act (FOCA) was introduced in the Senate by Barbara Boxer (CA-D) and in the House by Jarrold Nadler (NY-D). FOCA would be more radical than the *Roe v. Wade* decision because it would overturn the pro-life laws enacted by state legislators, allowed under *Roe.*

It's obvious to me that the strategy of the Silent No More Awareness Campaign is working; we are raising awareness about the consequences of abortion, and helping people connect with after-abortion care programs. Ultimately, I believe we will make abortion unthinkable and unnecessary because people will see that no one benefits. I pray that someday the Supreme Court will uphold a law that protects unborn children and entitles every expectant mother and her unborn child to the love and compassion they need

Considering Gonzales v. Carhart: Its Importance, The Future

April 18, 2007 is a day of historic importance for the pro-life movement and for all of American society. On that day the United States Supreme Court, in *Gonzales v. Carhart*, upheld the federal Partial-Birth Abortion Ban Act of 2003. This Supreme Court decision is of crucial importance for seven reasons. It also lays the groundwork, in three ways, for future pro-life progress.

WHY GONZALES IS IMPORTANT

- 1. *Gonzales*, for the first time since *Roe v. Wade* in 1973, upholds a law which actually bans, rather than merely regulates, a particular abortion procedure.
- 2. Gonzales allows a legislative ban of partial-birth abortion to stand without an unlimited health-of-the-mother exception. Recall that, according to the United States Supreme Court's Doe v. Bolton decision (1973), "health" has a very broad meaning in American abortion law: it includes "all factors—physical, emotional, psychological, familial, and the woman's age—relevant to the well-being of the patient." Inclusion of an unlimited health exception would have, for all practical purposes, nullified the legislated ban.
- 3. Gonzales emphasizes that the state has a legitimate interest in the life of the unborn child throughout pregnancy. Indeed, the decision refers to the state's right to "express profound respect for the life of the unborn" and affirms "that the government has a legitimate, substantial interest in preserving and promoting fetal life"
- 4. Gonzales asserts the state's "legitimate interest in regulating the medical profession in order to promote respect for life, including the life of the unborn." Therefore, the Court reminds the American medical profession to focus on sustaining, not taking, human life.
- 5. Gonzales reinforces the significance of informed consent. Writing for the majority, Justice Kennedy declares: "The state has an interest in ensuring so grave a choice is well informed. It is self-evident that a mother who comes to regret her choice to abort must struggle with grief more anguished and sorrow more profound when she learns, only after the event, what she once did not know: that she allowed a doctor to pierce the skull and vacuum the fast-developing brain of her unborn child, a child assuming the human form."
- **6.** Gonzales reminds us that elections matter. The elections of 2000, 2002, and 2004 made this U.S. Supreme Court decision possible. They elected many of the legislators who passed the 2003 Partial-Birth Abortion Ban Act, the President who nominated two new Supreme Court Justices, and the Senate which confirmed them.
- 7. Gonzales adopts a new legal language with which to discuss abortion. It oftentimes speaks of: "child" (not "fetus"), "mother" (not "woman"), and "abortion doctor" (not "physician").

GONZALES LAYS GROUNDWORK FOR THE FUTURE

- 1. Gonzales shows a new respect for the legislative branch of government and its moral discernment in responding to the challenge posed by abortion. This Court is less willing to tolerate a privileged status for the "right to abortion." This opens the door to more aggressive regulation of abortion by state and federal legislatures.
- 2. Gonzales encourages pro-life legislation based on abortion's negative impact on women.
- **3.** Gonzales demonstrates that the Court will be less likely to create a new "right to human cloning" or a new "right to destructive embryo research." Such legislative decisions, in light of this decision, will most likely be left to the states.

In conclusion, *Gonzales v. Carhart* stops the momentum of the abortion movement, calls American society to reconsider the matter of abortion with a new urgency and intensity, and motivates all witnesses for life in all the churches to rededicate themselves to works of mercy, education, and justice that will defend and advance the dignity of the unborn child and mother.


The Social Principles of The United Methodist Church state: "We oppose the use of late-term abortion known as dilation and extraction (partial-birth abortion) and call for the end of this practice except when the physical life of the mother is in danger and no other medical procedure is

available, or in the case of severe fetal anomalies incompatible with life." (Paragraph 161J, *The Book of Discipline*) The recent decision on partial-birth abortion allows the U.S. Congress to bring federal law, more or less, into line with this United Methodist social principle. Many United Methodists thank God for this development. At the same time, we recognize much remains to be done.

Lutherans for Life (LFL) is very pleased that the Supreme Court has upheld the Partial-Birth Abortion Ban. For the first time since *Roe v. Wade*, a line has finally been drawn to prohibit an abortion procedure. LFL finds hope in the language of Justice Kennedy's opinion, as quoted in the *New York Times* (April 18), that "the



LFL will continue to help Lutherans see abortion as a spiritual issue and equip them to teach others about the God-given value of human life from the moment of conception. That's where the line needs to be drawn. When "profound respect for life within the woman" is boldly and lovingly taught in our churches, and God's people make their voice known in society, perhaps then the day will come when unborn children will be safe in their mother's womb.

The Supreme Court decision to uphold the Partial-Birth Abortion Ban Act is a welcome sign of a shift in the attitude of the court. Of itself, it is not likely to reduce the incidence of abortions, nor does it address the moral and spiritual poverty of the decision to abort a child. It does ban one particularly gruesome procedure often used on viable



babies and for that we are grateful. As pro-life Presbyterians in a pro-abortion denomination (PCUSA), Presbyterians Pro-Life is accustomed to incremental victories. Always undergirding our celebration of those successes is the sadness that we are yet far from a pro-life view that accords with Scripture in viewing all life as created by God in His image and to be cherished, nurtured and protected until natural death. This decision of the Supreme Court holds a similar tension for the pro-life community in the public poll arena.
